IT IS HEREBY ENACTED by the Legislature of the State of Perak as follows:

1. This Enactment may be cited as the Loans (Water short title. Supplies) Enactment, 1959.

2. The State is hereby authorised, subject to the provi- Power to sions of this Enactment, to borrow from the Federation borrow money from sums of money not exceeding Fifteen million dollars on such the Federation.

3. The principal moneys borrowed under the provisions Loan to be of this Enactment together with all interest and other charged upon on the charges thereon are hereby charged on the State Consoli-State

4. (1) All moneys borrowed under the provisions of this Application Enactment shall be paid into the Perak State Water Supply of Loan. Fund created under sub-section (4) of section 26 of the Financial Procedure Ordinance, 1957, and shall be applied for the purpose of providing water supplies or for purposes ancillary thereto.
