An Enget An Enactment to apply a sum out of the Consolidated Fund for additional expenditure for the service of the year, 1959, to appropriate such a sum for certain purposes and to provide for the replacement of amounts advanced from the Contingencies Fund.

WHEREAS the sum of thirty-seven million, six hundred and eleven thousand, three hundred and thirteen dollars (\$37,611,313) has been provided by the Supply (1959) No. 7 of Enactment, 1958, and the Supplementary Supply (1959) No. 6 of Enactment, 1959, for the service of the year, 1959;

AND WHEREAS it is now requisite to make further provision of thirty-one thousand, one hundred and sixty-five dollars (\$31,165);

IT IS HEREBY ENACTED by the Legislature of the State of Perak as follows:

- 1. This Enactment may be cited as the Supplementary short title. Supply (1959) (No. 2) Enactment, 1959.
- 2. - 3. The replacement out of the amounts shown in the third column of the amounts shown in the fourth column of the First Schedule, being amounts advanced from the Contingencies Fund created under the Financial Procedure Ordinance, 1957, is hereby authorised.
- 4. (1) The issue of a further sum not exceeding one million and eighty thousand dollars (\$1,080,000) out of the Consolidated Fund is hereby authorised.
- (2) The amounts specified in the second column of the Second Schedule hereto are appropriated for the purposes of the accounts and funds specified in the first column thereof in addition to the amounts originally appropriated by the Supply (1958) Enactment, 1957, as specified in the third column of the Second Schedule hereto.
- (3) The State Financial Officer may from time to time direct that any sums appropriated under this section which are not required for the purposes for which they were appropriated shall be returned to the Consolidated Fund and, thereupon, the same shall be paid into the Consolidated Revenue Account.
