An Enactment to amend the State Public Service Commission Enactment, 1959.

IT IS HEREBY ENACTED by the Legislature of the State of Perak as follows:

Short title
and
commence-
ment.

1. This Enactment may be cited as the State Public Service Commission (Amendment) Enactment, 1975 and shall come into effect on the 1st day of March, 1975.

of Section 2.

2. Sub-section (2) of Section 2 of the State Public Service Commission Enactment, 1959, (hereinafter referred to as the Principal Enactment) is hereby amended by deleting the whole of paragraph (g).

Amendment
of Section
13.

3. The 3rd Schedule to the Principal Enactment is hereby amended as follows:

(a) by substituting the figure \$1,200.00 for the figure \$850.00 appearing in paragraph (a) of Clause 1;

(b) by substituting the figure \$400.00 for the figure \$250.00 and the figure \$30.00 for the figure \$25.00 and the figure \$850.00 for the figure \$500.00 respectively in paragraph (b) of Clause 1; and

(c) by substituting the figure \$200.00 for the figure \$75.00 appearing in paragraph (a) of Clause 2.
