**ENACTED** by the Legislature of the State of Perak Darul Ridzuan as follows:

**Short title**

1. This Enactment may be cited as the Supply Enactment 2009.

**Issue and appropriation for the service of the year 2009**

2. The issue of a sum not exceeding six hundred and forty-three million six hundred and eighty one thousand and two hundred and thirty-six ringgit (RM643,681,236.00) out of the Consolidated Fund for the service of the year 2009 is hereby authorized, and that sum is appropriated for the purposes specified in the Schedule.
