Perkhidmatan Awam Negeri, 1959

[ 01 JAN 1985 ]

ADALAH DENGAN INI DIPERBUAT UNDANG-UNDANG oleh Badan Perundangan Negeri Perak seperti berikut:

1. (1) Enakmen ini bolehlah dinamakan Enakmen Suruhanjaya Perkhidmatan Awam Negeri (Pindaan) 1986. Tajuk ringkas dan mula berkuatkuasa.

(2) Perenggan-perenggan (i) dan (ii) seksyen 2 Enakmen ini hendaklah disifatkan sebagai telah mula berkuatkuasa pada 1hb Julai 1977 dan perenggan (iii) dan (iv) seksyen 2 Enakmen ini hendaklah disifatkan sebagai telah mula berkuatkuasa pada 1hb Januari 1985.

2. Perenggan 2 Jadual Ketiga Enakmen Suruhanjaya Perkhidmatan Awam Negeri, 1959 adalah dipinda dengan: Pindaan kepada Jadual Ketiga. Enak.

(i) menggantikan perenggan-kecil (a) dengan yang berikut— 10/1959.

“(a) Quarters: Free furnished quarters as for officers in Division I of the public service of the State shall be provided or a housing allowance of \$200.00 per month shall be payable”;

- (ii) memasukkan selepas sahaja perenggan-kecil (a) perenggan-kecil baru (aa) seperti berikut—

“(aa) Telephone

Facilities: The cost of installing one telephone at his usual place of residence and the charges for periodical rentals including trunk call charges made on official business shall be payable”;

- (iii) memasukkan selepas sahaja perkataan “mensem” yang terdapat di perenggan-kecil (c) perkataan-perkataan “or a mileage allowance in accordance with paragraph 1 (e).”; dan

- (iv) menambahkan selepas sahaja perenggan-kecil (c) perenggan-kecil (d) baru yang berikut—

“(d) Driver’s

Salary Subsidy

Allowance: Driver’s salary subsidy allowance of \$250.00 per month shall be payable to the Chairman provided that—

- (1) a driver is engaged by him on a full time basis;
- (2) no Government driver is assigned to him; and
- (3) he shall not use a Government vehicle or a Government driver.”.

An Enactment to amend the State Public Service Commission Enactment, 1959.

[ 01 JAN 1985 ]

IT IS HEREBY ENACTED by the Legislature of the State of Perak as follows:

1. (1) This Enactment may be cited as the State Public Service Commission (Amendment) Enactment 1986.

Short title  
and  
commencement.

(2) Paragraphs (i) and (ii) of section 2 of this Enactment shall be deemed to have come into force on 1st July 1977 and paragraphs (iii) and (iv) of section 2 of this Enactment shall be deemed to have come into force on 1st January 1985.

2. Paragraph 2 of the Third Schedule of the State Public Service Commission Enactment, 1959 is amended by:

(i) substituting sub-paragraph (a) with the following—

“(a) Quarters: Free furnished quarters as for officers in Division I of the public service of the State shall be provided or a housing allowance of \$200.00 per month shall be payable”;

(ii) inserting immediately after sub-paragraph (a) the following new sub-paragraph (aa)—

“(aa) Telephone

Facilities: The cost of installing one telephone at his usual place of residence and the charges for periodical rentals including trunk call charges made on official business shall be payable”;

- (iii) inserting immediately after the word "mensem" appearing in sub-paragraph (c) the words "or a mileage allowance in accordance with paragraph 1 (e)."; and
- (iv) adding immediately after sub-paragraph (c) the following new sub-paragraph (d)—

"(d) Driver's

**Salary Subsidy**

**Allowance:** Driver's salary subsidy allowance of \$250.00 per month shall be payable to the Chairman provided that—

- (1) a driver is engaged by him on a full time basis;
- (2) no Government driver is assigned to him; and
- (3) he shall not use a Government vehicle or a Government driver.".
