DIPERBUAT oleh Badan Perundangan Negeri Perak Darul Ridzuan seperti berikut:

Tajuk ringkas dan permulaan kuat kuasa

1. (1) Enakmen ini bolehlah dinamakan Enakmen Setiausaha Kerajaan, Perak (Pemerbadanan)(Pindaan) 2004.

(2) Enakmen ini mula berkuat kuasa pada tarikh yang ditetapkan oleh Pihak Berkuasa Negeri melalui pemberitahuan dalam *Warta*.

Seksyen baru 4A

2. Enakmen Setiausaha Kerajaan, Perak (Pemerbadanan) 1951 [*Enakmen Bil. 3 Tahun 1951*], dipinda dengan memasukkan selepas seksyen 4 seksyen yang berikut:

"Additional powers of Corporation." 4A. (1) Subject to any written law, the Corporation shall have the power to do all things that are necessary for, or expedient or incidental to, the discharge of its duties and, without prejudice to the generality of the foregoing, shall have the power—

(a) to carry on all activities which appears to it to be requisite, advantageous or convenient for or in connection with the discharge of its duties;

- (b) to promote the carrying on of the activities of the Corporation, companies and other bodies of persons, and to give financial assistance to any corporation, company, other statutory authority, any body or person by the taking up of shares or debentures or by way of loan, advance, grant or otherwise;
 - (c) to acquire or to dispose of any stock and shares in any public or private company;
 - (d) to undertake ventures of a commercial or industrial nature, or to enter into a partnership or a joint venture with any person or organization;
 - (e) with the approval of the State Executive Council, to establish company or companies under the Companies Act 1965 or other body or bodies for the purpose of discharging any of its duties or exercising any of its powers either under the control or partial control of the Corporation itself or independently; or
 - (f) with the approval of the State Executive Council, to borrow from time to time any sums as may be required by the Corporation for meeting any of its obligations or discharging any of its duties or exercising any of its powers subject to such terms and conditions as may be imposed by the State Executive Council.

(2) For the purpose of paragraph (1)(e), no subsequent company or companies shall be established under the Companies Act 1965 by the company or companies established by the Corporation under that paragraph unless with the approval of the State Executive Council.".

An Enactment to amend the State Secretary, Perak (Incorporation) Enactment 1951.

[]

ENACTED by the Legislature of the State of Perak Darul Ridzuan as follows:

Short title and commencement

1. (1) This Enactment may be cited as the State Secretary, Perak (Incorporation) (Amendment) Enactment 2004.

(2) This Enactment comes into operation on a date to be appointed by the State Authority by notification in the *Gazette*.

New section 4A

2. The State Secretary, Perak (Incorporation) Enactment 1951 [*Enactment No. 3 Of 1951*], is amended by inserting after section 4 the following section:

"Additional powers of Corporation. 4A. (1) Subject to any written law, the Corporation shall have the power to do all things that are necessary for, or expedient or incidental to, the discharge of its duties and, without prejudice to the generality of the foregoing, shall have the power—

(a) to carry on all activities which appears to it to be requisite, advantageous or convenient for or in connection with the discharge of its duties;

- (b) to promote the carrying on of the activities of the Corporation, companies and other bodies of persons, and to give financial assistance to any corporation, company, other statutory authority, any body or person by the taking up of shares or debentures or by way of loan, advance, grant or otherwise;
 - (c) to acquire or to dispose of any stock and shares in any public or private company;
 - (d) to undertake ventures of a commercial or industrial nature, or to enter into a partnership or a joint venture with any person or organization;
 - (e) with the approval of the State Executive Council, to establish company or companies under the Companies Act 1965 or other body or bodies for the purpose of discharging any of its duties or exercising any of its powers either under the control or partial control of the Corporation itself or independently; or
 - (f) with the approval of the State Executive Council, to borrow from time to time any sums as may be required by the Corporation for meeting any of its obligations or discharging any of its duties or exercising any of its powers subject to such terms and conditions as may be imposed by the State Executive Council.

(2) For the purpose of paragraph (1)(e), no subsequent company or companies shall be established under the Companies Act 1965 by the company or companies established by the Corporation under that paragraph unless with the approval of the State Executive Council.".
