An Enactment to apply a sum out of the Consolidated Fund for additional expenditure for the service of the year 1962, and appropriate such a sum for certain purposes.

IT IS HEREBY ENACTED by the Legislature of the State of Perak as follows:

1. This Enactment may be cited as the Second Supplementary Supply (1962) Enactment, 1962. Short title.

2. (1) The issue of a sum not exceeding two million eight hundred and sixty-five thousand two hundred and one dollars (\$2,865,201) out of the Consolidated Fund for expenditure on the services specified in the Schedule for the service of the year 1962, not provided or not fully provided for by the Supply (1962) Enactment, 1961, and Perak State First Supplementary Supply (1962) Enactment, 1962, is hereby authorised. No. 14 of 1961.

(2) The said sum is appropriated for the purposes specified in the Schedule.
