An Enactment to provide for the allowances and privileges of the Official and Unofficial Members of the Dewan Negara Perak.

[1st January, 1962]

IT IS HEREBY ENACTED by the Legislature of the State of Perak as follows:

1. This Enactment may be cited as the Members of Dewan Negara Perak (Allowances and Privileges) Enactment, 1961, and shall come into force on the first day of January, 1962.
2. The allowances and privileges of an Official and Unofficial Member of Dewan Negara Perak (hereinafter in this Enactment referred to as a "member") shall be as specified in the Schedule hereunder. ~~at such rates and on such terms and conditions as may be~~
3. The sum required for the allowances and privileges payable under this Enactment shall be paid out of monies provided by the Legislative Assembly.
4. ~~The decision of the Ruler in Council on any question affecting the interpretation or construction of the Schedules shall be final.~~

SCHEDULE

Allowances and privileges for Official and Unofficial members:

1. CORRESPONDENCE—
A member shall have the authority to transmit free of charge all correspondence relating to Dewan Negara business.
2. MOTOR VEHICLE LICENCE—
A member shall be entitled to re-imbusement of any sum expended on a motor vehicle licence in respect of any one vehicle of which he is the registered owner.
3. FIREARM LICENCE—
A member shall be entitled to re-imbusement of any sum expended on any fees payable for any licence to possess and use of two firearms.
4. TELEPHONE FACILITIES—
A member shall be entitled to re-imbusement of any sum expended on cost of trunk calls made on Dewan Negara business.
5. MEDICAL FACILITIES—
A member, his wife and children shall be entitled to re-imbusement of any fee charged for medical attention at a Government Hospital (including operation fees, X'ray and electrotherapeutics) in First Class Wards, if available, provided that a ward fee of \$5 per day per person shall be payable by the member for such accommodation.

6. MILEAGE ALLOWANCE—

A member shall be entitled to claim mileage allowance at the rates set out hereunder for journeys connected with each meeting of the Dewan Negara or Committee thereof undertaken in a motor vehicle registered in his name under paragraph 2 of this Schedule:

Provided that a member who does not use or own a motor vehicle may claim re-imbursement of the actual travelling expenses incurred by him.

Rates of mileage allowance—

(a) any member holding office of emoluments shall claim mileage allowance according to rates payable to Government Officers;

(b) any other member shall be entitled to claim mileage allowance at the following rates:

7. SUBSISTENCE ALLOWANCE—

A member shall be entitled to a subsistence allowance of \$25 (twenty-five dollars) in respect of each meeting of Dewan Negara or the Committee thereof.

8. STATIONERY—

A reasonable supply of stationery will be provided by Government to Members of Dewan Negara. Indents for stationery should be made to the Secretary, Dewan Negara, Perak.

9. AUTHORITY CARDS—

Members shall be issued with authority cards.
