An Enactment to provide for the public service of the State for the year 1962.

[1st January, 1962]

IT IS HEREBY ENACTED by the Legislature of the State of Perak as follows:

1. This Enactment may be cited as the Supply (1962) Enactment, 1961, and shall come into operation on the 1st day of January, 1962. Short title and commencement.

2. (1) The issue of a sum not exceeding <sup>fifty-two million and sixty-eight thousand and forty dollars</sup> ~~fifty-one million~~ Issue and appropriation for service of 1962. ~~nine hundred and eighty-five thousand eight hundred and thirty dollars~~ (\$51,985,830) out of the Consolidated Fund for the service of the year 1962 is hereby authorised. (2) The said sum is appropriated for the purpose specified in the Schedule.
