An Enactment to provide for the public service of the State for the year 1963.

[1st January, 1963.]

IT IS HEREBY ENACTED by the Legislature of the State of Perak as follows:

1. This Enactment may be cited as the Supply (1963) Enactment, 1962, and shall come into operation on the 1st day of January, 1963. Short title and commencement.
2. (1) The issue of a sum not exceeding forty-eight million five hundred and thirty-four thousand seven hundred and twenty-four dollars (\$48,534,724) out of the Consolidated Fund for the service of the year 1963 is hereby authorised. Issue and appropriation for service of 1963.
- (2) The said sum is appropriated for the purpose specified in the Schedule.
