An Enactment to amend provisions relating to appeals from Kathis Courts.

IT IS HEREBY ENACTED by His Highness the Sultan with the advice and consent of the Council of State as follows:

Short title

1. This Enactment may be cited as the Courts (Perak Amendment) Enactment, 1955.

F.M.S. Enact. Cap. 2. 2. Section 67 of the Courts Enactment is hereby amended, in so far as it relates to the State of Perak, by deleting the words "Ruler of such State in State Council" and "Ruler of any State in State Council" wherever they occur in sub-sections (i), (iii), (iv) and (v) thereof and substituting therefor in each case the words "Ruler in Council".
