An Enactment to apply sums out of the Consolidated Fund to the service of the year 1958 and for the purposes of certain funds.

[1st January, 1958.]

IT IS HEREBY ENACTED by the Ruler with the advice and consent of the Council of State as follows:

1. This Enactment may be cited as the Supply (1958) Short title Enactment, 1957, and shall come into operation on the and commencement. 1st day of January, 1958.

2. (1) The issue of a sum not exceeding thirty-seven Issue and million, nine hundred and twenty thousand, five appropriation for hundred and seventy dollars (\$37,920,570) out of the service Consolidated Fund for the service of the year 1958 is of 1958. hereby authorised.

## No. 3 of 1957

(2) The said sum is appropriated for the purposes specified in the First Schedule.

Issue and appropriation for funds.

- 3. (1) The issue of a further sum not exceeding eleven million, eighty thousand, and ten dollars (\$11,080,010) out of the Consolidated Fund is hereby authorised.
- (2) The said sum is appropriated for the purposes of the funds specified in the Second Schedule.
- (3) The State Financial Officer may from time to time direct that any sums appropriated under this section which are not required for the purposes for which they were appropriated shall be returned to the Consolidated Fund and, thereupon, the same shall be paid into the Consolidated Revenue Account.
