An Enactment to apply a sum out of the Consolidated Fund for additional expenditure for the service of the year 1958, to appropriate such a sum for certain purposes and to provide for the replacement of amount advanced from the Contingencies Fund.

WHEREAS the sum of thirty-seven million nine hundred and thirty-nine thousand three hundred and seventy dollars (\$37,939,370) has been provided by the Supply (1958) Enactment, 1957, and the Supplementary Supply (1958) Enactment, 1958, for the service of the year 1958;

IT IS HEREBY ENACTED by the Ruler with the advice and consent of the Council of State as follows:

Short title.

1. This Enactment may be cited as the Supplementary Supply (1958) (No. 2) Enactment, 1958.

Further expenditure for year 1958.

2. (1) The issue of a sum not exceeding one hundred and seventy-three thousand six hundred and three dollars (\$173,603) out of the Consolidated Fund for expenditure on the various services specified in the Schedule for the service of the year 1958, not provided or not fully provided for by the Supply (1958) Enactment, 1957, and the Supplementary Supply (1958) Enactment, 1958, is hereby authorized.

(2) The said sum is appropriated for the purposes specified in the Schedule.

Replacement of amounts advanced from the Contingencies Fund. No. 62 of 1957.

3. The replacement out of the amounts shown in the third column of the amounts shown in the fourth column of the Schedule, being the amounts advanced from the Contingencies Fund created under the Financial Procedure Ordinance, 1957, is hereby authorized.
