An Enactment to make provision for the public service of the State for the year 1950.

[1st January, 1950.]

IT IS HEREBY ENACTED by His Highness the Sultan with the advice and consent of the Council of State as follows:

1. This Enactment may be cited as the Supply (1950) Short title Enactment, 1949, and shall come into operation on and com-mencement. the 1st day of January, 1950.

2. A sum not exceeding thirty million, one hundred Appropriaand fifty thousand and two hundred and thirteen dollars shall be and the same is hereby charged upon the revenues and other funds of the State of Perak for the service of the year 1950 and the said sum may be expended as specified in the Schedule to this Enactment.
