An Enactment to amend the First Part of the Laws of the Constitution of Perak.

[18th November, 1968.]

IT IS HEREBY ENACTED by the Legislature of the State of Perak as follows:

Short title  
and  
commencement.

1. This Enactment may be cited as the Laws of the Constitution of Perak (Amendment) Enactment, 1969, and shall be deemed to have come into force on 18th November, 1968.

Amendment  
of Article  
XXXVI.

2. Article XXXVI of the First Part of the Laws of the Constitution of Perak is hereby amended by inserting immediately after Clause (5) thereof the following—

“Provided that if a casual vacancy is established on a date within six months of the date the Legislative Assembly shall, in accordance with Clause (3) of this Article stand dissolved, such casual vacancy shall not be filled.”

Passed this 13th day of March, 1969.
