An Enactment to make supplementary provision for the public service of the State for the year 1954 [, 1955.]

IT IS HEREBY ENACTED by His Highness the Sultan of Perak with the advice and consent of the Council of State as follows:

1. This Enactment may be cited as the Supplementary Supply (1954) (Perak) Enactment, 1955.

2. A sum not exceeding three hundred and five thousand and fifty-one dollars and cents eighty-three is hereby charged upon the revenues and other funds of the State of Perak for the service of the year 1954 and the expenditure of the said sum as specified in the Schedule to this Enactment is hereby sanctioned and ratified.

An Enactment to make provision for the public service of the State for the year 1956.

[1st January, 1956.]

IT IS HEREBY ENACTED by His Highness the Sultan with the advice and consent of the Council of State as follows:

1. This Enactment may be cited as the Supply (1956) Enactment, 1955, and shall come into operation on the 1st day of January, 1956. Short title and commencement.

2. A sum not exceeding sixty million, one hundred and seventy-six thousand, seven hundred and forty-six dollars shall be and the same is hereby charged upon the revenues and other funds of the State of Perak for the service of the year 1956 and the said sum may be expended as specified in the Schedule to this Enactment.
