Scholarship Fund Enactment, 1951.

IT IS HEREBY ENACTED by the Legislature of the
State of Perak as follows:

Short title
and

1. This Enactment may be cited as the Perak Nationals (non-Malay) Scholarship Fund (Amendment) Enactment, 1965, and shall be deemed to have come into force on the 22nd day of June, 1965.

2. Sub-section (3) of section 6 of the Perak Nationals (non-Malay) Scholarship Fund Enactment, 1951, is hereby amended by substituting the words "State Secretary or his representative" for the words "Chief Education Officer" appearing therein.
