An Enactment to amend the First Part of the Laws of the
 Constitution of Perak.

[06 NOV 1964]

IT IS HEREBY ENACTED by the Legislature of the
 State of Perak in accordance with paragraph (4) of Article
 III of the First Part of the Laws of the Constitution of
 Perak as follows:

1. This Enactment may be cited as the First Part of the
 Laws of the Constitution of Perak (Amendment) Enactment,
 1964.

Short title
 and com-
 mencement.

2. The First Part of the Laws of the Constitution of Perak
 (hereinafter referred to as "the Principal Enactment") is
 hereby amended by inserting immediately after Article XVI
 thereof the following new Article:

New Article
 XVIIA.
 Added.

"XVIIA. (1) The Mentri Besar may appoint any person
 qualified to be a member of the Legislative Assembly
 to be his Political Secretary.

(2) A person appointed as a Political Secretary by
 virtue of this Article—

(a) may resign his office at any time;

(b) subject to paragraph (a) shall continue in office
 until such time as his appointment is deter-
 mined by the Mentri Besar;

(3) Before the Political Secretary exercises the
 functions of his office he shall take and subscribe in
 the presence of the Mentri Besar an Oath of Secrecy;

(4) The duties and functions of the Political Secretary
 and his remuneration shall be determined by the Ruler-
 in-Council."

3. Article XXXI of the Principal Enactment is hereby
 amended—

Amendment
 of Article
 XXXI.

(i) by inserting the following brackets and words, "(or,
 before Malaysia Day, in the territories comprised
 in the Borneo States or in Singapore)" imme-
 diately after the words "in the Federation"
 appearing in the second line of sub-paragraph
 (e) of paragraph (1) thereof, and by deleting the

word "have" appearing in the fifth line thereof and substituting therefor the word "has";

(ii) by deleting paragraph (2) thereof and substituting therefor the following:

"(2) The disqualification of a person under sub-paragraph (d) or sub-paragraph (e) of paragraph (1) may be removed by His Highness and shall, if not so removed, cease at the end of the period of five years beginning with the date on which the return mentioned in the said sub-paragraph (d) was required to be lodged or, as the case may be, the date on which the person convicted as mentioned in the said sub-paragraph (e) was released from custody or the date on which the fine mentioned in the said sub-paragraph (e) was imposed, and a person shall not be disqualified under sub-paragraph (g) of paragraph (1) by reason only of anything done by him before he became a citizen."

Amendment
of Article
XXXIII.

4. Article XXXIII of the Principal Enactment is hereby amended by adding at the end thereof the following proviso:

"Provided that this section shall not be taken to prevent the practice of the Assembly postponing a decision in order to allow for the taking or determination of any proceedings that may affect the decision (including proceedings for the removal of the disqualification)."

Amendment
of Article
XXXVI.

5. Article XXXVI of the Principal Enactment is hereby amended by deleting the word "occurs" at the end of paragraph (5) thereof and substituting therefor the words "is established that there is a vacancy."
