An Enactment to authorise the borrowing of a sum not exceeding ~~twenty million dollars~~ ^{three hundred and fifty million ringgit} from the Federation for certain purposes.

[25 AUG 1961]

IT IS HEREBY ENACTED by the Legislature of the State of Perak as follows:

1. This Enactment may be cited as the Loan (Low Cost Housing Schemes) (No. 2) Enactment, 1961. ^{Public} Short title.

2. In this Enactment—

^{Public} "Low Cost Housing Schemes" means schemes for the erection of dwelling houses and flats let out at gross rents not exceeding fifty dollars per mensem or sold on hire purchase terms not exceeding a net amount of thirty-five dollars per mensem.

3. The State is hereby authorised, subject to the provisions of this Enactment, to borrow from the Federation sums of money not exceeding ~~twenty million dollars~~ ^{three hundred and fifty million ringgit} on such terms and conditions as may be agreed upon between the State and the Federation.

Power to borrow money from the Federation. ^{Public} Encl. 4/78.

4. The principal moneys borrowed under the provisions of this Enactment together with all interests and other charges thereon are hereby charged on the State Consolidated Fund.

Loan to be charged upon on the State Consolidated Fund.

5. All moneys borrowed under the provisions of this Enactment shall be applied for the purpose of financing low cost housing schemes within the local authority or other areas specified in the schedule hereto and for all purposes ancillary thereto.

Application of Loan.

6. All moneys borrowed under the provisions of this Enactment, together with all interest and other charges thereon, shall be repaid in accordance with the terms and conditions agreed upon between the State and the Federation in accordance with section 3, and there shall be appropriated out of the State Consolidated Fund and paid to the Federation in each financial year all sums due to be paid.

Repayment.

7. The Ruler in Council may by order published in the *Gazette* add to, or otherwise amend, the Schedule hereto.
