An Enactment to amend the Perak Nationals (non-Malay) Scholarship Fund Enactment, 1951.

[1st January, 1969.]

IT IS HEREBY ENACTED by the Legislature of the State of Perak as follows:

Short title
and
commencement.

1. This Enactment may be cited as the Perak Nationals (non-Malay) Scholarship Fund (Amendment) Enactment, 1968, and shall come into force on the 1st day of January, 1969.

Amendment
of section
22.

2. Section 22 of the Principal Enactment is hereby repealed and the following substituted therefor:

“22. A member of the Board may be paid such travelling, lodging or other allowances as the Ruler in Council may from time to time prescribe for attending meetings of the Board or any Committee thereof.”
